- Acceptance of Registration. The il Corpo e L'Anima Academy has the right to accept or reject the registration request.
- Certificate delivery. The Coach Diploma, valid to request the ECC credential of ICF will be issued by the IL CORPO AND ANIMA ACADEMY at the end of the course after the following: balance payment, attendance of minimum 80% of the lessons, presentation of a thesis, passing of the theoretical-practical final verification tests. In the event of not passing the theoretical-practical final verification tests, but still ensuring the total payment, the attendance to minimum 80% of the lessons and the presentation of a thesis, an Attendance Certificate valid for registration to the relevant Associations (such as ICF and Sicool) will be issued. The participant will have the possibility to repeat the failed tests, in the conditions that will be established by the School.

- Course cancellation. In case of cancellation of the course for any reason not attributable to the member including the non-achievement of the minimum number of participants the amount paid by the member will be fully refunded.
- Cancellation from the subscriber. Under the articles 49, 52 and 54 of Legislative Decree 206/2005, the member has the right to back off from the contract, without indicating the reasons, within 14 days from registration to the training. The subscriber will have to send immediate written communication to [info@corpo-anima.it](mailto:info@corpo-anima.it) within the deadline of 14 days. If the member back off from the contract within the indicated term of 14 days, the full amount paid will be refunded. If the member withdraws from the contract after the 14 days deadline will be kept as penalty:
  - No amount in case of written cancellation over 60 days before the start of the course.
  - €250 in case of written cancellation done between 60 days and 30 days before the start of the course.
  - €450 in case of written cancellation done between 29 days and 15 days before the start of the course.
  - €700 in case of written cancellation done between 14 days and 4 days before the start of the course
  - The full amount paid in the event of written cancellation done within the last 3 days before the beginning of the course or if the course has already started.
